- 1. Call to Order at 6:00 PM
- 2. Pledge of Allegiance led by Chairman Reyes
- **3. Roll Call:** Chairman Reyes, present; Director Sandoval, present; Director Torres, absent.
- **4. Approval of Agenda:** Motion to approve agenda made by Director Sandoval; second by Chairman Reyes. Passed unanimously.

- **6. Chairman's Report:** Chairman Reyes stated he was pleased with the effort the Executive Engineer and Legal Counsel made in gaining NMFA Bond Approval.

- 8.3. NMFA Bond Sale Resolution Kevin Powers with RBC Capital Markets presented the finance plan for the 2011 Bond Sale, excluding the Placitas area. Chairman Reyes asked why RBC Capital Markets recommended using NMFA. Mr. Powers stated that NMFA offered the best value and they were on the approved list. Chris Muirhead with the Modrall Law Firm reviewed the 2011 General Obligation Bond Award Resolution with the Board. Motion to approve the NMFA Bond Sale Resolution made by Director Sandoval; second by Chairman Reyes. Motion to amend Section 3 of the NMFA Bond Sale Resolution to read "to provide that the bonds maturing on and after August 1, 2022 are subject to optional redemption on any date, in whole or in part, on or after August 1, 2021. Notice of redemption shall be provided to purchaser 30 days prior to redemption, via certified mail or electronic transmission", made by Chairman Reyes; second by Director Sandoval. Motion on the amendment passed with 2 in favor, none opposed. A roll call vote on the amended motion was taken with 2 in favor. Chairman Reyes yes

He stated that the EPA has indicated plans to issue a letter of designation, which will include ESCAFCA in the program. Mr. Castillo stated he has had a discussion with Sarah Holcomb of NM Environment

Department and plans to have a meeting with her in September to discuss the possibility of excluding ESCAFCA from the program.
